1] Why is this Code of Ethics important between Client & Universal Healer?

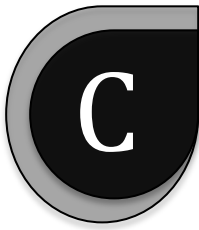

4] The Goals & Mission of the Practice

In all purest intentions, the Universal Healer is providing best solutions, personal and customized beliefs, thought forms, intentions, emotions and actions that will heal the client's behaviour, inner and outer reality towards a goal of self-awareness, journey to enlightenment and personal healing as well as individual spiritual freedom that in totality is to benefit the personal growth of the participant.

7] Commitment towards Mutual Goals

Both parties the Participant and Universal Healer has mutual goals, to enlighten the individual client towards greater consciousness and self-awareness thus liberating oneself towards spiritual freedom. At no point of time should the client make any assumptions or ungrounded accusations from doubt, fear, or negative disbeliefs to the Program or Universal Healer. It is recommended that the party carries Integrity in its intentions, and behaviour, words, actions that proves commitment towards completing the program.
